RULES AND REGULATIONS

1. PAYMENT deadline for entries is Thursday, **September 29, 2011.** There will be a **\$1.00 Admission fee into the Fiesta.** Vendors will receive **Two (2) free Admittance Bands for entry into the grounds.**
2. Entry fee, by cash, check or money order made out to Coleman Co. Chamber of Commerce, **MUST** accompany entry form and is **non-refundable** and **MUST BE RECEIVED IN THE CHAMBER OFFICE BY September 28, 2011.**
3. Participants must check in at **FIESTA HEADQUARTERS AT THE BILL FRANKLIN CENTER OFFICE AREA** for space location. Check in time is 7:00 a.m. 9:00 a.m. Saturday, October 1, 2011. Early entrance into the Fiesta will be located at the **NORTH GATE OF THE RODEO GROUNDS & 24TH STREET.**
4. Exhibitors will be responsible for their own backdrop, chairs, tables, electrical cords, etc. All food booth spaces are required to provide a large trash container with plastic bags. Allied Waste will provide large trash bins located in the area for vendors to dispose of their trash. **All vendors are responsible for the cleanliness around their booth.**
5. Fiesta activities begin at 9:00 a.m. and participants **MUST KEEP THEIR BOOTHS OPEN UNTIL 5:00 P.M.,** Saturday.
6. Food booths will be located **LOCATED ON THE DANCE PAVILION AREA.** SEE FOOD BOOTH RULES. **
7. Vehicles **WILL NOT** be allowed in the Fiesta area after unloading.
8. If you are promoting a business, club, or organization, you are welcome to set up in the Arts & Crafts Booth area.
9. No one can set up booths until after 2:00 p.m. Friday, September 30, 2011.
10. **CHAMBER IS NOT RESPONSIBLE FOR LOST OR STOLEN GOODS, LOST EQUIPMENT OR ACCIDENTS.**

FORBIDDEN ITEMS: No Water Shooting Devices of Any Sort Allowed. No Stink Bombs or Fire Works of Any Kind Allowed. No Confetti, Silly String, or Blow Guns Allowed and No Itching or Sneezing Powder Allowed. Any type of pellet gun is not allowed. No Imitation Cigarettes.
